Privacy

Samba Co-operative Limited takes your privacy and the protection of your personal information very seriously and we will only use your personal information in accordance with this policy and any applicable legislation.

We have implemented reasonable technical and operational measures to keep your personal information secure.

You may provide personal information to us directly by completing an application form or through our website, per telephone, CCTV cameras, digital recordings or any other means.

In instances where you have applied for credit and given us permission we may conduct a search regarding your credit history at credit bureaus. Record of our enquiry will be kept by the credit bureaus and will also be available to other entities enquiring about your credit history.

Use of information collected

We may use, transfer and disclose your personal information for the purposes of:

- Managing your contractual relationship with us;
- Detecting and preventing fraud or money laundering;
- Assessing and dealing with complaints and requests;
- Operational, marketing, auditing, statistical, legal and record keeping requirements;

- Transmitting to a registered credit bureau any information concerning your application for credit, our agreement with you, account history, termination and non-compliance with the terms thereof;
- Complying with any applicable legislation;
- Recording of telephone and electronic communications;
- Conducting market research.

Disclosure of your information Your information may be shared with selected third parties who process the information on our behalf.

Under certain circumstances you have the right to request the destruction or deletion of the information held about you or to restrict the processing of your information. If you wish to exercise this right please contact our Information Officer. This may however influence our ability to provide our products and services to you.

Complaints

Complaints regarding the utilisation of your personal information can be referred to our Information Officer. If you are not satisfied with the resolution process you have the right to lodge a complaint with the Information Regulator.
